#### 1. Context and Background

Habitat for Humanity is a global nonprofit housing organization working in local communities across all 50 states in the U.S. and in approximately 70 countries. Habitat's vision is of a world where everyone has a decent place to live.

Habitat works toward our vision by building strength, stability and self-reliance in partnership with families in need of decent and affordable housing. Habitat homeowners help build their own homes alongside volunteers and pay an affordable mortgage.

Habitat for Humanity International Nepal is an international non-governmental organization that builds decent and affordable housing in partnership with people in need. The organization serves families with low income, families who are landless, vulnerable, socially excluded, disaster-affected, or living in disaster-prone areas to build adequate and accessible homes promoting dignity and hope to support sustainable and transformational development. Habitat Nepal serves the most vulnerable people through the provision and promotion of decent housing, water & sanitation, housing microfinance, and advocacy on land & housing rights with an emphasis on DR3 (Disaster Risk Reduction and Response), gender equality, and the person with disabilities.

As Habitat continues its ambitious strategy that requires a shift in programming putting program quality and impact at the core, the need to gather evidence to demonstrate the positive changes in the lives of those impacted through the provision of adequate housing has grown significantly. While some research and related literature reviews have been made over the years within and external to the Habitat network which have attempted to capture the transformational impacts of housing, these have most often had a focus on a particular thematic area while the impacts of housing have tended to be incidental rather than intentional.

There is a unique opportunity in Nepal to undertake a comparative analysis of population groups and review of related research that could provide an assessment of theories on the transformational impacts of housing through the lens of Habitat's work.

The populations of interest will include groups living in the same geographical area, with a sub-group composed of an initial approximate population of 250 families participating in Habitat interventions through housing projects. A second sub-group will include those who do not participate in Habitat interventions and hence continue to live in current conditions where improvements are undertaken without external assistance. A third sub-group will include families in the same areas who participate in the Nepal Government's People's housing program through which they move to live in their new homes. It is vital to emphasize that the research will focus on the provision of adequate housing and related basic services and not on the relocation aspects. While qualitative studies tend to be less definitive compared to quantitative studies, the comparative study would optimize use of the most significant change approach to build evidence between the three population groups to enable sound technical analysis.

#### 2. Objectives

The research aims to gather evidence on the broader impacts of housing through a comparative analysis of three sub-groups in Nepal. The research will test the impact that Habitat's and the Government's People's Housing Program's adequate housing initiatives can deliver, including those the project directly, indirectly, and cumulatively contributed to, demonstrated through positive health, education, and economic changes in the lives of vulnerable families.

# **Use of study findings**

How will study findings be used?

The research is envisaged to provide direction for future research on housing impacts and design of effective programs. The research is envisaged to provide a detailed quantifiable evidence base of the broader impacts of housing which will be leveraged to prioritize housing amongst stakeholders including government and donors.

#### Key study questions

## **Key study question envisioned:**

How does the measurable impact of Habitat's housing on households compare with those in the People's Housing Program and those who have not received assistance in relation to health, livelihoods, social cohesion, food security, gender, economic growth, equality, climate resilience, dignity, MPI, risk reduction capacities of communities.

## To explore the above question, the following have to be looked into:

#### A. Contextual information:

- What are the current conditions of the compared target communities in terms of demography, social issues faced, and access to basic services including health, education, and economic opportunities?
- What are the conditions surrounding communities and groups with access to Habitat's interventions, i.e., types of frequency of support received?
- What is the current condition of the compared target communities in terms of geographical and cultural diversity.
- What is the current condition of the compared target communities in terms of gender equity and social inclusion.

## B. Project indicators:

• Establish the baseline, mid-line and end-line values of predefined impact indicators of adequate housing projects. (i.e., relevant indicators for health, education and socioeconomic outcomes and impact for both treatment and nontreatment groups.

The consultant will further develop the key study questions to gather relevant evidence on the broader impacts of housing.

The Scope of work proposed for Year 1 is as follows. The consultant can further expand and

Consultation with the Habitat team and supporting university will be required at intervals across the year. The frequency and duration are tentatively proposed.

# 4. Methodology

Quantitative and qualitative methods and tools are envisioned for the study. The following is the proposed methodology. The consultant can further expand and propose a revised methodology as they see fit aligned with the objective.

- Household survey of treatment and non-treatment households.
- FGD, in-depth interviews of key respondents from both groups.
- Comparative analysis this is address by including treatment and nontreatment groups in the survey/studies with replication by geography and ethnicities/religions.
- Most Significant Change analysis this will be used during mid-line or endline survey
   I.e., during or after intervention.
- Census (TBD) secondary data analysis and it will be used only for comparing changes between the two Census.
- Literature review of previous studies/research internationally and in Nepal i.e., Hilti Baseline Study's findings can be used to validate the finding of the correct survey.

## 5. Target Groups

Geographical Scope and Sampling Method:

- Three population groups composed of Marginalised Indigenous and Dalit communities in the province of South-Eastern Terai, in the five districts of Dhanusha, Siraha, Morang, Saptari, Sunsari
- Group A (250 households) are those participating in Habitat programs
- Group B (250 households) are those NOT participating in Habitat programs
- Group C are those participating in the Government's housing program proposed as a second "treatment" group in the same five districts with at least 30 households per district (approximately 150 households)

Characteristics of the families: The socio-economic characteristics of the families compared need to be similar. The following are base comparison criteria.

- Income level (low-income families)
- Caste Indigenous or Dalit

## 6. Key Deliverables

The following are the key deliverables:

- 1. Research methodology for a 5-year comparative study.
- 2. Detailed research methodology report for the initial 1 year.
- 3. Final list of indicators for impact of adequate housing.
- 4. Literature review.
- 5. Survey tools and data matrix for qualitative and quantitative data collection.
- 6. Clean datasets, raw data in editable version (include translated interview/FGD transcripts, photos and videos).
- 7. Analyzed tables in MS Excel.
- 8. Quarterly reports, final report. All to be shared in soft copy.
- 9. Workshop reports, coordination meeting minutes of engagement with relevant stakeholders.
- 10. Revised recommendation methodology for years 2-5.

## 7. Qualifications, skills, and experience

The consultancy team should have the following qualifications, skills and experience within their team:

- 1. Proven knowledge of the housing ecosystem.
- 2. Proven competencies and relevant work experience in conducting qualitative and quantitative studies, in-depth analysis of and reporting on the outcomes and impacts

- of development programs in relation to health, education, livelihood, and gender equity and social inclusion of communities.
- 3. Knowledge of health, education, livelihood, gender equity, and social development policies, practices, and government and non-government structures in Nepal.
- 4. Proven competency in developing and using tools and methods, explicitly, conducting literature review, household-level surveys, focus group discussions, key informant interviews with different respondent groups, including women, community members.
- 5. Demonstrated experience in data management ethics and methodologies: recording, processing visualization, and analysis.
- 6. Excellent computer skills with high proficiency in Microsoft Word, Excel; practical experience using, information management systems and analysis software particularly for qualitative data such as NVIVO, Kobo, SPSS, etc.
- 7. Proven experience in coordinating with diverse teams
- 8. Effective, high-quality communication, writing, and interpersonal skills are essential.
- 9. Professional fluency in spoken and written English, and ability to communicate concisely with impact; high-level English writing skills are mandatory.
- 10. Ability to manage teams with the capacity to communicate effectively with local communities in Nepal.
- 11. Ability to present and communicate findings effectively and coherently to a diverse range of audiences through written, verbal and graphical means.

# 9. Ethical Protocols

Similarly, Habitat Nepal will deposit reverse VAT at the rate of 13% of the total invoice amount to the Inland Revenue Department of the Government of Nepal.
- 2. If the proposal is submitted by a Nepali firm registered in the VAT, Habitat Nepal will withhold an applicable Tax Deduction at Source (TDS) of 1.5% on payment and deposit the amount to the Inland Revenue Department of the Government of Nepal.
