#### 1. About Habitat for Humanity Nepal

Habitat for Humanity Nepal is an international non-governmental organization that is driven by the vision that everyone deserves a decent place to live. Our partnership with communities, governments, private sector including entrepreneurs and financial institutions, youth networks, and academia, allows us to serve low-income families by improving habitability, tenure security, access to basic services and affordability of housing solutions. Our integrated programming serves to benefit 2.7 million people over the next three years, through direct and incremental construction, affordable housing finance, affordable construction technologies and services, and evidence-based policy advocacy for housing adequacy as a fundamental right. Responding to the root causes of inequity in the housing ecosystem, Habitat Nepal leads with a systems-strengthening approach, facilitating development of inclusive housing markets, removing key policy barriers and empowering communities through people-centered approaches, for a stronger and more equitable housing ecosystem.

### 2. Background

With the financial support of Jersey Overseas Aid (JOA), Habitat Nepal and Sahara Nepal are going to implement "Housing Opportunities and Microfinance Solutions (HOMES) Project". The project is designed to sustainably improve financial literacy knowledge and reduce poor housing conditions amongst low and medium-income households in Koshi (2 districts) and Madhesh (3 districts) provinces of Nepal, particularly in Sunsari, Udaypur, Saptari, Siraha and Dhanusha districts. In this regard, Habitat Nepal is seeking to recruit an experienced consultant (firm/individual) to conduct a baseline survey of the project. This baseline survey aims to find out the outcome and impact indicators values will be created through the activities that will be conducted during the coming four years of the project.

#### 3. Objective

The main objective of TOR is to conduct a baseline survey to assess the baseline value of outcome and impact indicators. These values will be used to measure project achievements through measuring changes on these indicators' values conducting midline and endline surveys with designated comparison group.

The specific objectives are:

- To assess the current values of outcomes and impacts indicators related to health, education and social economic condition of the potential homeowners and comparison group.
- To assess current knowledge attitude and practice of financial literacy training on financial behavior of the potential households who will receive financial literacy training (potential beneficiaries) and who will not receive financial literacy training (comparison group).
- To assess the current knowledge and awareness levels of potential and comparison households regarding safe shelter, housing micro-finance, housing micro-insurance and housing green energy.

#### 4. Scope of Work

The scope of the baseline survey is to assess the context of access to finance, safe shelter and housing green energy in five districts where the project implementation will take place during the project period. It aims to gather input and feedback from various stakeholders to improve the project activities implementation qualities from:

- a) Potential MFIs clients that will receive housing micro finance loans.
- b) Potential households that will participate in financial literacy training (FLT).
- c) Potential participants who will take part in or be exposed to awareness raising activities, which include video screening, rally, booklet/pamphlet distribution, broadcasting through radio, electrical signpost advertisement, public interaction on FLT, housing micro-finance, housing micro-insurance, housing green energy and safe shelter, collaboration with school/club/ self-help group and training to end users, during project implementation period.
- d) Representatives from the four MFIs involved in the project, namely: Sahara Nepal Saving and Credit Cooperative Limited, Jeevan Bikash Laghubitta Bittiya Sanstha Limited, Forward Microfinance Laghubitta Bittiya Sanstha Limited and Mahuli Laghubitta Bittiya Sanstha Limited.

By engaging with these stakeholders, the survey aims to comprehensively assess the current outcomes and impacts indicators values of project and access to finance context.

#### 5. Methodology

Based on the objectives and scope of work the consultant individual/firm should propose an appropriate survey methodology, experimental design framework and sample size to provide comprehensive baseline values of the project outcome and impact indicators on its beneficiaries.

Total HHs in the 17 local levels of 5 districts is 183,168 and households by caste/ethnicities categories are provided in above table. There is a requirement that samples should be taken based on 5% margin and error and 95% confidence level by each stratum i.e., caste/ethnic categories and the sample units should be divided by proportionately per Municipality.

# 8. Qualifications, Skills, and Experience

Habitat Nepal is looking for a consultant firm having the following qualifications:

**Technical Expertise:** The consultant/firm should have at least 5 years of demonstrating relevant experiences in monitoring and evaluating community support, financial inclusion and other microfinance projects.

**Survey and Evaluation Experience:** Proven competency in designing and implementing baseline, midline, and endline studies, including analysis and reporting on outcomes and impacts of safe, adequate, and affordable housing interventions in relation to health, education, livelihood, and social development.

**Knowledge of Local Context:** In-depth understanding of health, nutrition, education, livelihood, and social development policies, practices, and governance structures in Nepal (governmental and non-governmental).

**Data Integration and Analysis:** Strong skills in systematic collection, integration, and analysis of qualitative and quantitative data.

**Research Tools and Methods:** Experience in developing and using research tools, including literature reviews, household surveys, focus group discussions, and key informant interviews with diverse respondent groups (e.g., women, community members, government, and non-government stakeholders).

**Ethics and Methodology:** Proven experience in applying ethical standards in data collection, processing, and analysis.

**Technical Proficiency:** Excellent computer skills with high proficiency in Microsoft Word and Excel; practical experience with information management and analysis software such as Kobo, ODK, SPSS, or equivalent.

**Team Coordination:** Demonstrated ability to coordinate effectively with diverse teams.

**Communication Skills:** High-quality writing, reporting, and interpersonal communication skills.

**Language Proficiency:** Professional fluency in spoken and written English and Nepali, with advanced English writing skills mandatory for concise and impactful communication.

#### 9. Evaluation Criteria

70% of the weightage is assigned to the technical proposal and 30% to the financial proposal. Technical proposals securing less than 50 out of the total possible 70 will be disqualified. The proposal that scores the highest based on the sum of technical and financial proposal scores will be selected.

#### 10. Coordination and supervision

Under the supervision of Senior Research and MEAL Manager, the consultant will work closely with Habitat Nepal's HOMES Project Manager and MEAL teams. The consultants will be required to undergo a session on Habitat's Safeguarding policies as part of the onboarding process.

- 1. If proposal is submitted by PAN registered individual person, Habitat Nepal will withhold applicable Tax Deduction at Source (TDS) of 15% of the total budget
- 2. If the firm or individual is registered in VAT, Habitat Nepal will withhold applicable TDS as per rule of Government of Nepal.
