## 1. About Habitat for Humanity Nepal

Habitat for Humanity Nepal is an international non-governmental organization that is driven by the vision that everyone deserves a decent place to live. Our partnership with communities, governments, private sector including entrepreneurs and financial institutions, youth networks, and academia, allows us to serve low-income families by improving habitability, tenure security, access to basic services and affordability of housing solutions. Our integrated programming serves to benefit 2.7 million people over the next three years, through direct and incremental construction, affordable housing finance, affordable construction technologies and services, and evidence-based policy advocacy for housing adequacy as a fundamental right. Responding to the root causes of inequity in the housing ecosystem, Habitat Nepal leads with a systems-strengthening approach, facilitating development of inclusive housing markets, removing key policy barriers and empowering communities through people-centered approaches, for a stronger and more equitable housing ecosystem.

#### 2. Background

Through this assignment, Habitat Nepal aims to establish the current values of its outcome and impact indicators as per project phase-III logical framework. These benchmarks will serve as the foundation for measuring progress and assessing project achievements during the endline evaluation of IMPACT 2026 project, a seven-year funding commitment supported by The Hilti Foundation. At the same time the survey will also assess the achievements on outcome and impact indicators of phase-II comparing it with the baseline values of indicators established during phase-II.

Therefore, the survey will serve as:

- The endline survey for phase-II of Impact 2026,
- The midline survey for the overall seven-year funding commitment supported by The Hilti Foundation and
- The baseline survey of phase-III.

The findings will not only provide a reference point for tracking project performance but also generate insights into the achievement status of Impact 2026: Phases I and II and inform evidence-based programming and improved implementation for Impact 2026 project phase-III.

Phase-III of the IMPACT 2026 project builds upon the achievements of phases-II, with a strong focus on consolidating innovations and scaling bamboo housing solutions across Eastern Nepal. The project is conceptualized for seven years in three contiguous phases, with phase-III serving as the consolidation phase.

# 8. Qualifications, Skills, and Experience

Habitat Nepal is looking for a consultant firm having the following qualifications:

**Technical Expertise:** Demonstrated capacity to conduct studies in housing and settlements, with cross-cutting knowledge in health, WASH, education, and livelihood.

**Survey and Evaluation Experience:** Proven competency in designing and implementing baseline, midline, and endline studies, including analysis and reporting on outcomes and impacts of safe, adequate, and affordable housing interventions in relation to health, education, livelihood, and social development.

**Knowledge of Local Context:** In-depth understanding of health, nutrition, education, livelihood, and social development policies, practices, and governance structures in Nepal (governmental and non-governmental).

**Data Integration and Analysis:** Strong skills in systematic collection, integration, and analysis of qualitative and quantitative data.

**Research Tools and Methods:** Experience in developing and using research tools, including literature reviews, household surveys, focus group discussions, and key informant interviews with diverse respondent groups (e.g., women, community members, government, and non-government stakeholders).

**Ethics and Methodology:** Proven experience in applying ethical standards in data collection, processing, and analysis.

**Technical Proficiency:** Excellent computer skills with high proficiency in Microsoft Word and Excel; practical experience with information management and analysis software such as Kobo, ODK, SPSS, or equivalent.

**Team Coordination:** Demonstrated ability to coordinate effectively with diverse teams.

Communication Skills: High-quality writing, reporting, and interpersonal communication skills.

**Language Proficiency:** Professional fluency in spoken and written English and Nepali, with advanced English writing skills mandatory for concise and impactful communication.

## 9. Evaluation Criteria

70% weightage is assigned to the technical proposal and 30% to the financial proposal. Technical proposals securing less than 50 out of the total 70 will be disqualified. The proposal that scores the highest based on the sum of technical and financial proposal scores will be selected.

## 10. Coordination and supervision

Under the supervision of Senior Research and MEAL Manager, the consultant will work closely with Habitat Nepal's Impact 2026: Phase III Project Manager and MEAL teams. The consultants will be required to undergo a session on Habitat's Safeguarding policies as part of the onboarding process.
